## Introduction of Leading Organiser 籌辦機構簡介

### Hong Kong Wireless Technology Industry Association (WTIA)

Hong Kong Wireless Technology Industry Association (WTIA), established in 2001, is a not-for-profit trade association dedicated to the wireless and innovative technology industry. The Association acts as a platform, an aggregator, and a community for industry professionals to advance and facilitate the development of wireless, mobile, and emerging innovative technologies. ## Background 背景

The Hong Kong ICT Awards (HKICTA) aims at recognising and promoting outstanding information and communications technology (ICT) inventions and applications, thereby encouraging innovation and excellence among Hong Kong's ICT talent and enterprises in their constant pursuit of creative and better solutions to meet business and social needs.

The HKICTA was established in 2006 with the collaborative efforts of the industry, academia and the Government. Organised by the Office of the Government Chief Information Officer, and led by Hong Kong ICT industry associations and professional bodies, the Awards aims at building a locally espoused and internationally acclaimed brand of ICT awards.

There are eight categories under the HKICTA 2024. There will be one Grand Award in each category, and an "Award of the Year" will be selected from the eight Grand Awards by the Grand Judging Panel. In addition, in a bid to foster the innovative use of artificial intelligence (AI), each of the eight categories will establish a new distinguished accolade: the "Best Use of AI" award, magnifying and honouring outstanding achievements in harnessing the power of AI in respective areas.

### 香港無線科技商會

香港無線科技商會(WTIA)成立於2001年，是一個非盈利機構，為從事創新科技的企業提供中立的資訊平台，以促進業界發展。本會作為業界樞紐，致力推廣社會各界對無線及創新科技的關注，以及提倡創新科技及流動技術方案的開發和應用。

二十多年來，香港無線科技商會一直受同業支持，擔任業界與政府溝通的橋樑。每年透過舉辦各種線上線下活動以匯聚業界精英，攜手集中發展本會六大重點項目：

- 5G與物聯網
- 區塊鏈與元宇宙
- 行動商務與金融科技
- 初創培育
- 教育科技
- 資訊安全

香港資訊及通訊科技獎旨在表揚及推廣優秀的資訊及通訊科技發明和應用，以鼓勵香港業界精英和企業不斷追求創新和卓越，謀求更佳和更具創意的方案，滿足企業的營運需要，造福社會。

通過業界、學術界和政府的共同努力，香港資訊及通訊科技獎於二零零六年成立。香港資訊及通訊科技獎由政府資訊科技總監辦公室舉辦，並由香港業界組織及專業團體籌辦，目的是為香港建立一個廣受香港社會愛戴、並獲國際認同的資訊及通訊科技專業獎項。

2024香港資訊及通訊科技獎設有八個類別的獎項。每個類別均設有一個大獎，而最終評審委員會會再從八個大獎中甄選出「全年大獎」。此外，為了激發更多人工智能的創新應用，每個獎項類別都會增設一個嶄新獎項：「最佳人工智能應用」獎，以彰顯並表揚那些在相關範疇應用人工智能方面取得傑出成就的參賽作品。

## Objective 目的

Hong Kong ICT Awards 2024: ICT Startup Award aims at discovering and recognising the outstanding local ICT startup companies which focus on software, hardware and social innovation areas and, reward their distinguished development based on their growth, innovation, creativity, functionality, market potential and performance.

## Prizes and Benefits for Winners 得獎者的獎勵

The remarkable achievements of the Awards winners (Gold/Silver/Bronze) will be recognised by customers, organisations, the ICT industry practitioners and across the community. Winners will be entitled –

- to receive trophies (Gold/Silver/Bronze) of the HKICTA;
- to display the official logo of the HKICTA in their promotional materials;
- to participate in various promotional campaigns to publicise their achievements;
- to be supported for entering into other regional and international awards and competitions;
- to 3 months free access to Lion Rock 72 (co-working space in InnoCentre) or co-working space in Hong Kong Science Park Incubation Centre for SMEs ;<sup>[1]</sup>
- to participate in investment matching activities co-organised by the Hong Kong Business Angel Network (HKBAN) and Hong Kong Science and Technology Parks Corporation (HKSTPC);
- to 3 months free access to Flexi Space in Cyberport Smart-Space for SMEs ;<sup>[2]</sup>
- to receive Green Channel Interview (conditional<sup>[3]</sup>) offer of “HK Tech 300 Seed Fund” by City University of Hong Kong (CityU). The awardee will receive up to HKD100,000 in funding and other support from the programme (<https://www.cityu.edu.hk/hktech300/about-hk-tech-300/hk-tech-300-seed-fund>) (For Student Innovation category, only Stream IV “Higher Education” winners are eligible) after passing through the interview; and
- to free participation in some large-scale local ICT events (e.g. InnoEX) for marketing exposure.

2024香港資訊及通訊科技獎:資訊科技初創企業獎旨在鼓勵及表揚本地出色的軟件、硬件和社會創新領域的初創公司，根據其發展、創新、創意力、功能性、市場潛力及比表現褒獎其傑出的發展。

香港資訊及通訊科技獎金/ 銀/ 銅得獎者的卓越成就備受各方賞識，包括客戶、機構、業界人士、以至整個社會。得獎者可獲得：

- 授予金/ 銀/ 銅獎之獎座；
- 授權在宣傳物品上展示香港資訊及通訊科技獎的標誌；
- 安排於不同類型的推廣活動中宣傳其得獎項目；
- 協助參加其他區域及國際性獎項和比賽；
- 免費使用創新中心內的初創協作基地「Lion Rock 72」或位於香港科學園培育中心的共享工作空間三個月(只限於中小企業)；<sup>[1]</sup>
- 參與香港天使投資脈絡及香港科技園共同舉辦的投資配對活動；
- 免費使用數碼港共享工作空間Smart-Space內的靈活辦公桌三個月(只限於中小企業)；<sup>[2]</sup>

## General Eligibility Requirements 一般參賽資格

1. The applicant must have the intellectual property right and/or legitimate right over the ICT product/service mentioned in the application. The applicant shall disclose disputes any place over the world over intellectual property right about the applicant's ICT product/service, if any, for the Leading Organiser to consider eligibility of the application.
2. The application must be submitted by locally (Hong Kong) registered entities (please enclose Company/Business Registration proof) or residents in Hong Kong<sup>[4]</sup> at the time of closing for entry enrolment.
3. A significant part of the innovation, design, research and development (R&D) of the mentioned ICT product/service must come from resources in Hong Kong. The applicant should demonstrate significant value-add by the Hong Kong resources contributing to the success of the ICT product/service in the target market.
4. With the exception of the Student Innovation category, the submitted product/service must have been available<sup>[5]</sup> in the market for at least 3 months or in live operation for at least 3 months at the time of closing for entry enrolment (please enclose proof – e.g. delivery note, invoice, public announcement, advertisement, internal announcement, etc.).
5. The same application is only allowed to be submitted to a maximum of ONE award stream among all the Categories. Any application found to have entered into more than one award stream will be disqualified.
6. Winning entries of the Gold/Silver/Bronze award in previous years of the HKICT Awards can enter the Awards again only if there is significant change or enhancement in the product/service, or for a new award category.

1. 參賽者必須擁有參賽項目所述資訊及通訊科技產品/服務的知識產權及/或合法權益。有關資訊及通訊科技產品/服務如在世界任何地方發生知識產權的爭議，參賽者必須披露，供籌辦機構考慮其參賽資格。
2. 參賽者必須在截止報名時為香港註冊公司（請附上公司/商業登記證明）、機構或香港居民<sup>[4]</sup>。
3. 參賽的資訊及通訊科技產品/服務項目在創新、設計和研究發展方面的重要部分必須源自香港。參賽者須展示香港資源為其資訊及通訊科技產品/服務帶來顯著增值，促使有關項目在目標市場取得成功。
4. 除學生獎項類別外，參賽的資訊及通訊科技產品/服務項目必須在截止報名日期前已經在市場上公开发售最少三個月/或開放予下載應用<sup>[5]</sup>或已經投入運作最少三個月（請附上證明——例如送貨單、發票、外發公告、廣告、內部通告等）。
5. 同一參賽項目只可參加各獎項類別的其中一個獎項組別。任何項目如被發現報名參加多於一個獎項組別，將被取消資格。
6. 過往香港資訊及通訊科技獎金、銀、銅得獎項目的產品/服務，必須已作出重大修改或優化，或參加另一個獎項類別，方可再次參賽。

## Rules and Regulations 參賽規則

1. An eligible Startup Applicant must be **incorporated no more than 5 years** by the end of the application deadline.
2. Therefore, the company **must be incorporated after 12 July 2019** according to its **Certificate of Incorporation** or equivalent supporting documents.
3. Applicants are advised to be aware of the best practice and case-based experience as promulgated by the Office of Privacy Commissioner for Personal Data.
4. Applicants are reminded that any person who, without the permission of Steering Committee of Hong Kong ICT Awards, offers an advantage to parties involved in the Awards as a reward or inducement for doing any act or showing favour in relation to the Awards commits an offence of the Prevention of Bribery Ordinance (Cap. 201).
5. To avoid conflicts of interest and the perception as such, applications for the Awards from sponsors will not be accepted.
6. In case of any dispute, the decision of the Leading Organiser will be final and binding on all parties concerned.

1. 以截止報名日期為準，合資格參賽初創公司**成立日期必須不多於五年**。
2. 根據其公司註冊處的**公司註冊證明書**或相關證明，**參賽公司須於2019年7月12日後成立**。
3. 參賽者需留意由私隱專員公署所制訂的最佳行事方式指引及個案經驗。
4. 參賽者須注意，根據《防止賄賂條例》（香港法例第 201 章），任何人士如未經香港資訊及通訊科技獎督導委員會許可，向任何參與該獎項事務的工作人員提供任何利益，作為該工作人員作出任何以其工作身分而作的行為的報酬或誘因，或作為與申請該獎時給予任何優待或提供任何協助的報酬或誘因，即屬違法。
5. 為避免利益衝突或任何有關利益衝突的嫌疑，香港資訊及通訊科技獎贊助商的參賽申請將不會被接納。
6. 如有任何爭議，籌辦機構保留最終決定權，參賽者不得異議。

## Award Streams 獎項組別

Applicants may **select one of the following** three streams:

### 1. Software and Apps

To recognise the ICT startup companies with products / services in the category of mobile apps, software and related services, basic research, gaming, etc.

### 2. Hardware and Devices

To recognise the ICT startup companies with products / services in the category of Internet of Things, wearable devices and various kind of smart devices, medical equipment, robotics and innovation that leverage hardware as a delivery platform.

### 3. Social Impact

To recognise the ICT startup companies that innovate, launch, create social impact related service, program, platform, etc.

參賽者可於以下**其中一個組別**參賽:

### 1. 軟件及應用程式

旨在表揚提供產品/服務、移動應用、軟件、基礎研究，遊戲等類別之初創公司。

### 2. 硬件與設備

旨在表揚提供以硬體形式作為展現平台之產品/服務，物聯網，可穿戴產品和各種智能設備、醫療設備、機械人技術和創新的範疇的初創公司。

### 3. 社會貢獻

旨在表揚提供為社會作出貢獻服務、程式、平台等的初創公司。

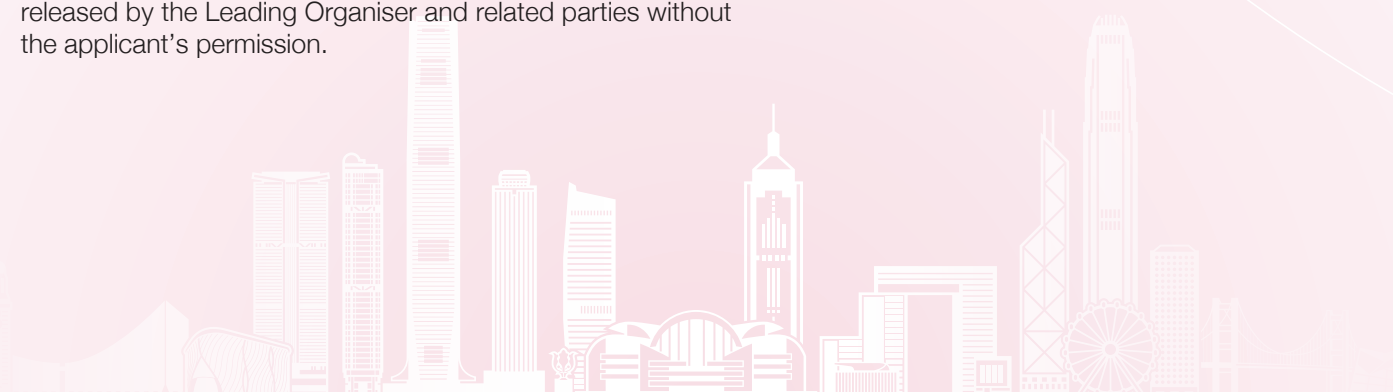

The applicant will be notified in advance if such access is required. Any information supplied by the applicant for the purpose of the Hong Kong ICT Awards 2024 will be treated as confidential, and will not be released by the Leading Organiser and related parties without the applicant's permission.

1. An authorised e-signature.
2. A copy of the [Business Registration Certificate\(BR\)](#) of the entrant or equivalent supporting document.
3. A copy of the [Certificate of Incorporation\(CI\)](#) of the entrant or equivalent supporting document.
4. A copy of [at least 3-months in live Operation Proof \(OP\) of the submitted solution or product](#) (e.g., delivery note to customer, invoice, public announcement, advertisement, internal announcement, update record of applications etc.)
5. Additional supplementary information (if any).

### IMPORTANT NOTICE

Entrants shall receive a notification email automatically generated by the system upon submitting the Online Application Form.

The ICT Startup Award Secretariat Office will officially send a [confirmation letter](#) along with an [Application Reference Number](#) to the contact person(s)'s email to confirm the application [within 2 working days](#).

If entrants have submitted the Online Application Form but did not receive the official confirmation letter within 2 working days after the submission. Please immediately contact the Secretariat Office at [ictstartup@hkwtia.org](mailto:ictstartup@hkwtia.org) or 2989 9164 for instant assistance.

Information supplied by the entrants will be taken into account by the Judging Panel when assessing the merit of the companies, such as product or software sample, catalogues, photographs and any other relevant materials. The entrants should be prepared to demonstrate the product if requested.
