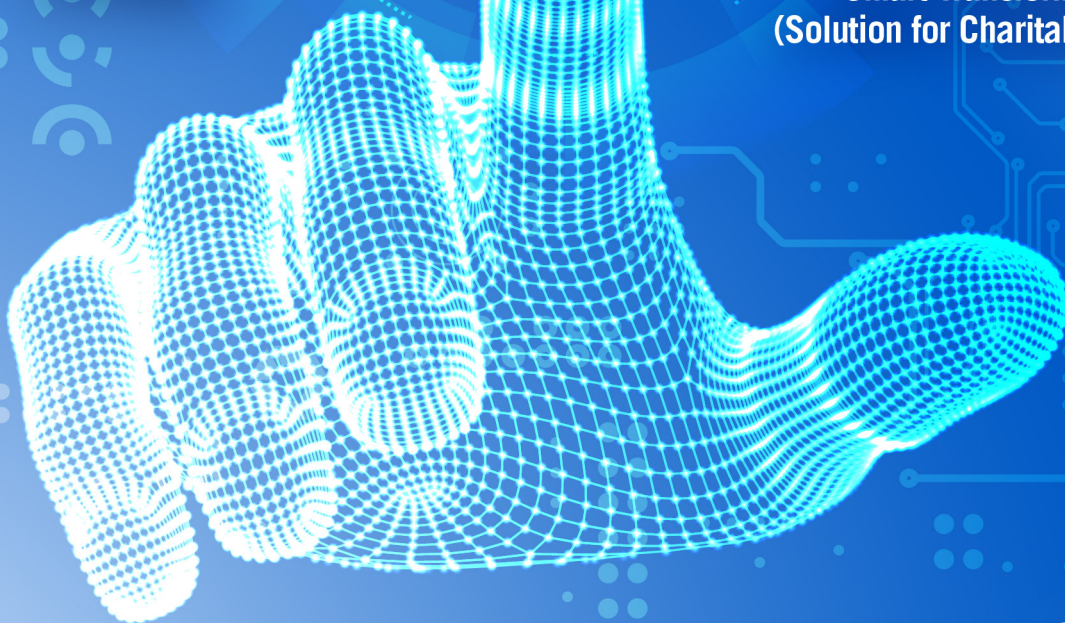

# Smart People Award 智慧市民獎

## Introduction of Leading Organiser 籌辦機構簡介

The Hong Kong Council of Social Service (HKCSS) is a statutory body established in 1947. Together with our Agency Members, we uphold social justice and equality in our mission to advance the well-being of the Hong Kong community. The HKCSS is committed to building an impact-oriented, collaborative and innovative social service sector, and co-creating a better society with stakeholders across different sectors. The HKCSS has over 510 Agency Members, with service units throughout Hong Kong, providing high-quality social services to those in need.

香港社會服務聯會（簡稱「社聯」）為法定團體，於1947年成立，與機構會員共同信守社會的公義、公平，以社會福祉為依歸。社聯致力帶動一個具影響力、彼此合作、靈活創新的社會服務界，並透過跨界別協作，與各持份者同行共創。社聯現時有超過510個機構會員，其服務單位遍布全港，為市民提供優質社會服務。

## Background 背景

The Hong Kong ICT Awards (HKICTA) aims at recognising and promoting outstanding information and communications technology (ICT) inventions and applications, thereby encouraging innovation and excellence among Hong Kong's ICT talent and enterprises in their constant pursuit of creative and better solutions to meet business and social needs.

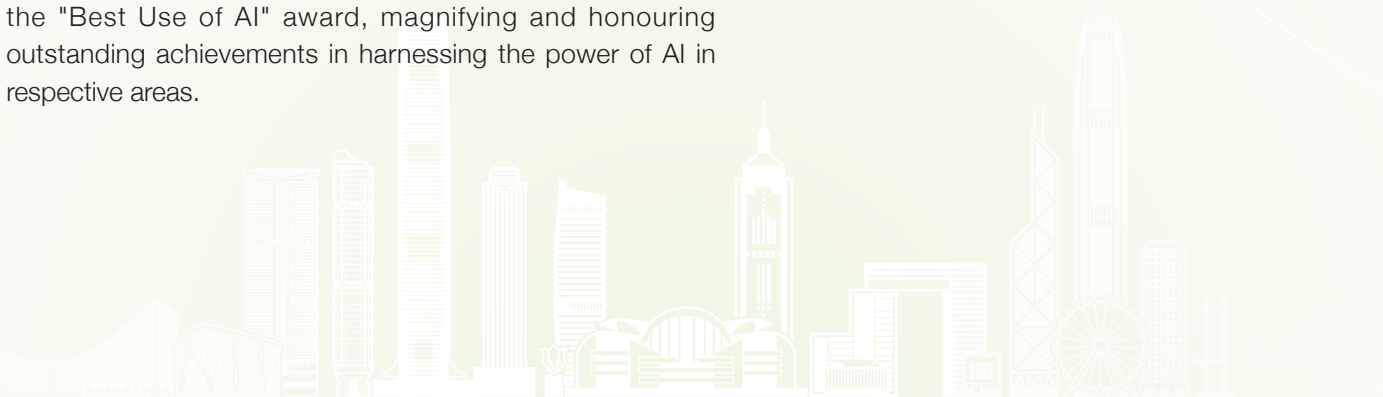
香港資訊及通訊科技獎旨在表揚及推廣優秀的資訊及通訊科技發明和應用，以鼓勵香港業界精英和企業不斷追求創新和卓越，謀求更佳和更具創意的方案，滿足企業的營運需要，造福社會。

The HKICTA was established in 2006 with the collaborative efforts of the industry, academia and the Government. Organised by the Office of the Government Chief Information Officer, and led by Hong Kong ICT industry associations and professional bodies, the Awards aims at building a locally espoused and internationally acclaimed brand of ICT awards.

通過業界、學術界和政府的共同努力，香港資訊及通訊科技獎於二零零六年成立。香港資訊及通訊科技獎由政府資訊科技總監辦公室舉辦，並由香港業界組織及專業團體籌辦，目的是為香港建立一個廣受香港社會愛戴、並獲國際認同的資訊及通訊科技專業獎項。

There are eight categories under the HKICTA 2024. There will be one Grand Award in each category, and an "Award of the Year" will be selected from the eight Grand Awards by the Grand Judging Panel. In addition, in a bid to foster the innovative use of artificial intelligence (AI), each of the eight categories will establish a new distinguished accolade: the "Best Use of AI" award, magnifying and honouring outstanding achievements in harnessing the power of AI in respective areas.

2024 香港資訊及通訊科技獎設有八個類別的獎項。每個類別均設有一個大獎，而最終評審委員會會再從八個大獎中甄選出「全年大獎」。此外，為了激發更多人工智能的創新應用，每個獎項類別都會增設一個嶄新獎項：「最佳人工智能應用」獎，以彰顯並表揚那些在相關範疇應用人工智能方面取得傑出成就的參賽作品。



## Objective 目的

Hong Kong ICT Awards 2024: Smart People Award is established to recognise innovative development of ICT products / solutions or ICT-enabled services with the following objectives:

1. To achieve “ageing in place” and to enhance the sustainability of an ageing society
2. To improve the underprivileged’s circumstances and quality of life, safeguard their right in social participation, and no one being marginalized in the smart city development
3. To enable charitable institutions achieving higher operation productivity and efficiency, improving client experience and ultimately enhancing the quality of life of their targeted clients

## Prizes and Benefits for Winners 得獎者的獎勵

The remarkable achievements of the Awards winners (Gold/Silver/Bronze) will be recognised by customers, organisations, the ICT industry practitioners and across the community. Winners will be entitled –

- to receive trophies (Gold/Silver/Bronze) of the HKICTA;
- to display the official logo of the HKICTA in their promotional materials;
- to participate in various promotional campaigns to publicise their achievements;
- to be supported for entering into other regional and international awards and competitions;
- to 3 months free access to Lion Rock 72 (co-working space in InnoCentre) or co-working space in Hong Kong Science Park Incubation Centre for SMEs<sup>1</sup>;
- to participate in investment matching activities co-organised by the Hong Kong Business Angel Network (HKBAN) and Hong Kong Science and Technology Parks Corporation (HKSTPC);

「2024 香港資訊及通訊科技獎：智慧市民獎」旨在表揚社會各界致力發展創新資訊科技產品，並投入資訊科技於服務中，目的如下：

1. 推動「居家養老」和增強老齡化社會的可持續性
2. 改善弱勢社群的生活狀況和質素，保障他們在智慧城市發展中的社會參與權利，防止其被邊緣化
3. 協助慈善機構提升運營生產能力和效率，提升服務使用者的體驗，從而提升服務使用者的生活質素

香港資訊及通訊科技獎金 / 銀 / 銅得獎者的卓越成就備受各方賞識，包括客戶、機構、業界人士、以至整個社會。得獎者可獲得：

- 授予金 / 銀 / 銅獎之獎座；
- 授權在宣傳物品上展示香港資訊及通訊科技獎的標誌；
- 安排於不同類型的推廣活動中宣傳其得獎項目；
- 協助參加其他區域及國際性獎項和比賽；
- 免費使用創新中心內的初創協作基地「Lion Rock 72」或位於香港科學園培育中心的共享工作空間三個月（只限於中小企業）<sup>1</sup>；
- 參與香港天使投資脈絡及香港科技園共同舉辦的投資配對活動；

The awardee will receive up to HKD100,000 in funding and other support from the programme (<https://www.cityu.edu.hk/hktech300/about-hk-tech-300/hk-tech-300-seed-fund>) (For Student Innovation category, only Stream IV “Higher Education” winners are eligible) after passing through the interview;
- to free participation in some large-scale local ICT events (e.g. InnoEX) for marketing exposure;
- to promote the awarded product/solution on the SocTech Hub e-platform and events hosted by HKCSS Social Enterprise Limited – Information Technology Resource Centre

## General Eligibility Requirements 一般參賽資格

1. The applicant must have the intellectual property right and/ or legitimate right over the ICT product/service mentioned in the application. The applicant shall disclose disputes any place over the world over intellectual property right about the applicant's ICT product/service, if any, for the Leading Organiser to consider eligibility of the application.
  2. The application must be submitted by locally (Hong Kong) registered entities (please enclose Company/Business Registration proof) or residents in Hong Kong<sup>4</sup> at the time of closing for entry enrolment.
  3. A significant part of the innovation, design, research and development (R&D) of the mentioned ICT product/service must come from resources in Hong Kong. The applicant should demonstrate significant value-add by the Hong Kong resources contributing to the success of the ICT product/service in the target market.
  4. With the exception of the Student Innovation category, the submitted product/service must have been available<sup>5</sup> in the market for at least 3 months or in live operation for at least 3 months at the time of closing for entry enrolment (please enclose proof – e.g. delivery note, invoice, public announcement, advertisement, internal announcement, etc.).
  5. The same application is only allowed to be submitted to a maximum of ONE award stream among all the Categories. Any application found to have entered into more than one award stream will be disqualified.
  6. Winning entries of the Gold/Silver/Bronze award in previous years of the HKICT Awards can enter the Awards again only if there is significant change or enhancement in the product/service, or for a new award category.
1. 參賽者必須擁有參賽項目所述資訊及通訊科技產品 / 服務的知識產權及 / 或合法權益。有關資訊及通訊科技產品 / 服務如在世界任何地方發生知識產權的爭議，參賽者必須披露，供籌辦機構考慮其參賽資格。
  2. 參賽者必須在截止報名時為香港註冊公司（請附上公司 / 商業登記證明）、機構或香港居民<sup>4</sup>。
  3. 參賽的資訊及通訊科技產品 / 服務項目在創新、設計和研究發展方面的重要部分必須源自香港。參賽者須展示香港資源為其資訊及通訊科技產品 / 服務帶來顯著增值，促使有關項目在目標市場取得成功。
  4. 除學生獎項類別外，參賽的資訊及通訊科技產品 / 服務項目必須在截止報名日期前已經在市場上公开发售最少三個月 / 或開放予下載應用<sup>5</sup> 或已經投入運作最少三個月（請附上證明 — 例如送貨單、發票、外發公告、廣告、內部通告等）。
  5. 同一參賽項目只可參加各獎項類別的其中一個獎項組別。任何項目如被發現報名參加多於一個獎項組別，將被取消資格。
  6. 過往香港資訊及通訊科技獎金、銀、銅得獎項目的產品 / 服務，必須已作出重大修改或優化，或參加另一個獎項類別，方可再次參賽。

1. Applicants are advised to be aware of the best practice and case-based experience as promulgated by the Office of Privacy Commissioner for Personal Data.
  2. Applicants are reminded that any person who, without the permission of Steering Committee of Hong Kong ICT Awards, offers an advantage to parties involved in the Awards as a reward or inducement for doing any act or showing favour in relation to the Awards commits an offence of the Prevention of Bribery Ordinance (Cap. 201).
  3. To avoid conflicts of interest and the perception as such, applications for the Awards from sponsors will not be accepted.
  4. In case of any dispute, the decision of the Leading Organiser will be final and binding on all parties concerned.

  4. 如有任何爭議，籌辦機構保留最終決定權，參賽者不得異議。

## Award Streams

### 獎項組別

#### 1. Smart Ageing

The Award aims to recognise innovative development of gerontechnological products / solutions or ICT-enabled services, programmes and campaigns to enable independent living and social participation of elderly people in good health, comfort and safety, which is believed to be an important factor to achieve “ageing in place” and to enhance the sustainability of an ageing society.

#### 2. Smart Empowerment

This Award aims to recognise more “client-centric” innovative development of products / solutions or ICT-enabled services, programmes and campaigns to address unique challenges faced by the underprivileged in the community, to improve their circumstances and quality of life, safeguard their right in social participation, and no one being marginalized in the smart city development.

#### 3. Smart Transformation (Solution for Charitable Sector)

This Award aims to recognise innovative development of products/ solutions or ICT-enabled services, programmes and campaigns to enable charitable institutions achieving higher operation productivity and efficiency, improving client experience, service effectiveness and quality, and ultimately enhancing the quality of life of their targeted clients.

#### 1. 智慧樂齡

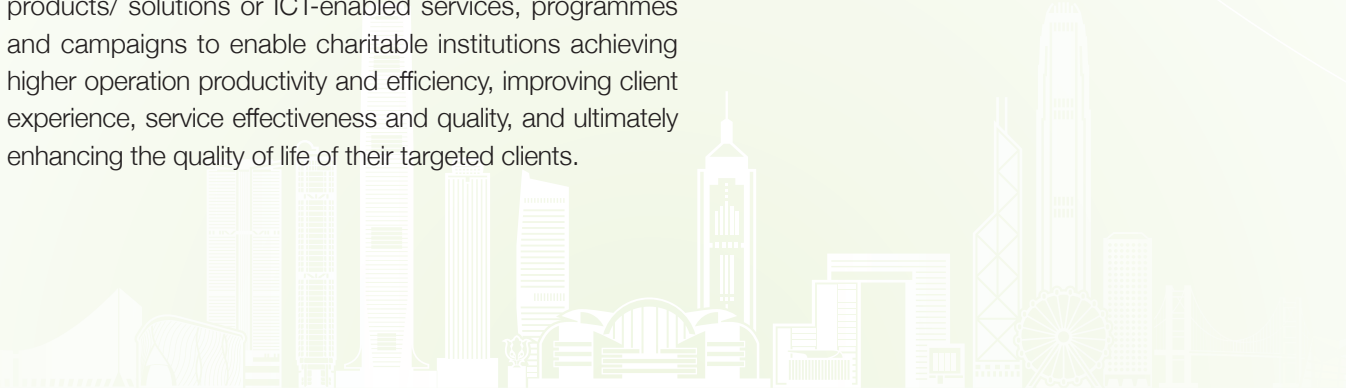
該獎項旨在表揚創新的資訊及通訊科技產品 / 方案或應用資訊及通訊科技推行的服務、計劃及活動，推動「居家養老」和增強老齡化社會的可持續性，讓長者能夠在良好的健康、舒適和安全的環境下，能夠獨立生活並參與社交活動。

#### 2. 智慧充權

該獎項旨在表揚創新的資訊及通訊科技產品 / 方案或應用資訊及通訊科技推行的服務、計劃及活動，應對社區中弱勢社群所面臨的挑戰，改善其生活狀況和質素，保障他們在智慧城市發展中的社會參與權利，防止其被邊緣化。

#### 3. 智慧轉型 (慈善機構方案)

該獎項旨在表揚創新的資訊及通訊科技產品 / 方案或應用資訊及通訊科技推行的服務、計劃及活動，協助慈善機構提升運營生產能力和效率，提升服務使用者的體驗、服務效能和質素，從而提升服務使用者的生活質素。
